2. The technical and financial proposals will be evaluated as per criteria of 80% & 20% weight-age respectively. The financial proposal of those firms will be considered for evaluation that gets technically qualified.
3. In order to familiarize with the project and local conditions, the consulting firms can visit the project area. It should be clearly understand that any cost incurred for collection of preliminary information, for preparation of proposals or for subsequent visit will not be reimbursable.
4. Any request for additional information, would be responded expeditiously but any delay in collection of information will not be considered a reason for extending date of submission of proposals.
