2. The Technical and Financial proposals will be evaluated as per criteria of 80% & 20% weight-age respectively. The financial proposals of those firms will be considered for evaluation that gets technically qualified.
3. In order to familiarize with the project and local condition the consulting firm can visit the project area. It should be clearly understand that any cost incurred for collection of preliminary information, for preparation of proposals or for subsequent visit will not be reimbursable.
4. Any request for additional information, would be responded expeditiously but any delay in collection of information will not be considered a reason for extending date of submission of proposals.
5. The firms are expected to visit sites/area before the pre-bid meeting scheduled to be held in the office of undersigned on 10/07/2017 at 11:00 am to discuss the issues, if any. All the consulting firms are requested to convey their comments or any other clarification (s) required to the undersigned three (03) days before the pre-bid meeting. The pre-bid meeting will not be held in case no comments/clarifications from Consultants side received.

Detail Technical and Financial proposals separately sealed may be prepared in English and two copies clearly mentioned as "original" and "duplicate" and shall reach at the following address in sealed cover till 11 am on 17/07/2017. Technical proposals will be opened on the same day at 12 pm in the presence of bidder's representatives whose chose to attend.
