- ii. Bids should accompany all necessary documents like copies of CNIC, PEC/ Income Tax Reg: etc
- iii. The winning bidder will have to deposit additional call deposit @ 8% in case the bid is below 10% of the engineer estimate/BOQ and submit with the original bid documents. Photo copy may be attached with the duplicate.
- iv. The bids are required to be submitted through registered mail or courier service alongwith original CDR/Demand Draft.
- v. The contractor/firm should not quote "Above" or Below on the tender form and BOQ but rather the total bid cost be recorded both in figures and words.
- vi. Award of contract/contracts will be strictly according to the criteria laid down by PEC and reflected in the "Instructions to bidders" and in light of PPRA Rules.
- vii. The Contractor will not sublet the project or any part of it. Any violation in this regard may lead to confiscation of his earnest money besides blacklisting.
- viii. Government taxes will be charged as per rules
- ix. Disfiguring / overwriting, elusion and fudging shall render the bid to rejection.
- x. Only the first three figures after the decimal of the rate will be considered for evaluation of bids.
- xi. Completion period of both the projects will be 18 months.
