Terms & Conditions

- Bid Documents including BOQ can be obtained from the office of the undersigned by the owner of the firm/legal representative from the date of publication in the newspaper till 06-01-2017.
- Cost of tender form/documents as mentioned above are payable through demand draft or pay order (non refundable) in the name of Chief Executive FATA Development Authority. The same is to be furnished alongwith the bid documents.
- 2% Earnest money as mentioned above must be accompanied with the application for issuing of documents in the shape of call deposit in the name of Chief Executive FATA DA from scheduled banks of Pakistan.
- Copies of the requisite documents alongwith CNIC, enlistment, renewal, income tax and registration of Pakistan Engineering Council etc must be attached with the tender documents .
- The representatives of the firm should have authority letter dully attested by notary public.
- The contract shall be awarded to the contractor/bidder whose evaluated bid is the lowest and meets the specifications and quality needs of the procuring entity. In case the contractor quotes bid below 10% of the Engineer's estimate / BoQ, the bid shall stand rejected. The call deposit shall be accepted subject to verification from the issuing bank.
- Sealed bids sent through registered mail/courier should reach upto 11:00 AM on the dates mentioned above and will be opened at 12:00 Noon on the same date in presence of original bidders/their legal representatives who choose to attend the opening. The delay in delivery of the tender documents will be the responsibility of the bidder.
- The contractor/firm both will not only quote above / below on the tender form and BOQ but the total bid cost should invariably be written in the tender form in words and figures.
- In case bid become tie, the award of contract shall be decided through a free draw.
- All taxes including income tax and sale tax will be recoverable as per rules of the government issued from time to time.
- Any document, submitted alongwith the bidding document, found false/bogus, the registration of the contractor/firm shall stand cancelled/blacklisted.
- Any disfiguring / overwriting, manipulation in the tender shall be liable to rejection.
- Only the first two figures after the decimal of the rate will be considered for evaluation of the bid.
- Incomplete / conditional bid will not be acceptable.
- FATA DA may reject all bids or proposals at any stage of the bidding process.
- Pre-bid meeting will be held in office of the undersigned at 11:00 AM on 04-01-2017.
